

# Terms and Conditions

## 1. Definition and interpretation

- 1.1 NGF is the Nederlandse Golf Federatie, the NSGV is part of this association
- 1.2 Associations are part of the NSGV and may have their own rules
- 1.3 Member is a person who subscribed for the membership.
- 1.4 Dutch law and jurisdiction is applicable when becoming a member of NSGV, and it is applicable on all organised events organised.

## 2. Membership

- 2.1 A membership is an agreement between the NSGV and a person and continues until
  - 2.1.1 The member unsubscribes, or the association ceased to exist.
  - 2.1.2 The member is suspended by the board as stated in the statute of the NSGV.
- 2.2 The member should unsubscribe before the 30th of June
- 2.3 The membership includes
  - 2.4.1 A handicap registration at the NGF
  - 2.4.2 Opportunities to participate in activities organized by the NSGV. For these activities an additional fee may be charged.
- 2.4 The member is obliged to have completed the subscription by paying the membership fee if applicable for a society a sports-card/membership at the Student Sport Centre may be needed, else the subscription is not completed.

## 3. Fees and payment

- 3.1 The membership fee for a full year is decided yearly by the board in euro's.
- 3.2 The membership fee for a half year is also decided yearly by the board in euro's.
- 3.3 For additional activities an additional fee can be charged.

## 4. Driving Range Rules

- 4.1 At all times one should pay attention to everyone's safety
- 4.2 Careful use of materials

## 5. Equipment and facilities

- 5.1 The facilities may include depending on the society the driving range, clubhouse, toilet and mats from which balls can be hit.

## 6. Limitation of liability

- 6.1 NSGV does not carry any responsibility with regard to personal injury or loss of belongings.
- 6.2 Every member has a limited insurance at the NGF (Nederlandse Golf Federatie)

## 7. Tournaments

- 7.1 NSGV or other societies may organise an own tournament that members can participate in

## 8. Changes to terms and conditions

- 8.1 Changes to the terms and conditions can be made by the board, possibly from input of the general assembly.
- 8.2 The changes should be communicated to all the members upon which they can decide to stay or leave the society.

## 9. Use of personal information

- 9.1 By becoming a member of NSGV, you accept the privacy policy of the association. The privacy policy can be found on the website of the NGF
- 9.2 The NSGV is part of the NGF so your personal data will be shared, this is necessary to provide for a handicap registration.
- 9.3 A member has the right to
  - access the personal information the association has on the member
  - request errors in the information to be corrected
  - receive a copy of all the personal information
  - let irrelevant personal information for the association be removed
- 9.4 The sitting board of the association is responsible for the protection of the personal information of all the members. Questions about your personal information should be directed to the secretary of the board.

## 10. Complaints

- 10.1 Complaints can be made towards any member of the current board.
- 10.2 The complaints should be dealt with adequately
  - 10.2.1 If the complained is of such a concern that it affects other members, the complaint should be dealt with during a general assembly.
